Whether you are a treatment provider, therapist, residential staff member or in another role where you work with youth exhibiting sexually abusive behaviors, it can be difficult to bridge the divide that exists between understanding the theory of trauma and attachment models and actually doing something with that theory. In other words, you know what it looks like but so what? How does the theory translate to the practice of working with a youth who is sexually abusive, in terms of not only managing potential behaviors, but also in treating the issue?

In this session we will look at what we can do to bring this understanding alive. Through demonstration and discussion, a model of working through the 'trauma-centric lens' and looking for teachable moments – with a focus on youth exhibiting sexually abusive behaviors – will be suggested. The presentation aims to be interactive – audience input is not only welcomed but encouraged.

Seminar Objectives:

- To define sexually abusive behaviour (what is/what isn't) and language to use or not use
- To gain understanding of the underlying theories in regards to treatment of sexually abusive youth: what's hot and what's not?
- To incorporate child developmental knowledge into our practice; what's normal and what's not?
- Sexually abusive behaviours versus sex offending
- Trauma/attachment/brain development: how this paradigm is useful in treatment
- To look at Therapeutic Treatment Order legislation and why it's good news for families
- To walk away with practical strategies in regards to assessment and/or treatment
- To separate or not? When is the risk too high to others for a young person to stay in the home
